1. Current Situation


1.1 Account balance


The 2011 result is therefore a profit of 2 826,77 €.



It was the leftover donations this association collected for Mageia just after the project announcement, while we were installing our own donation platform. Cash income (€ 860.00) comes from tee-shirt sales at FOSDEM 2011.

2.4 Facts

- Mageia trademark registration runs for 10 years (should be geographically extended).
- We reinforced (and still need to) our collaboration platform infrastructure (more servers for QA & packagers, new backup server, new backup hard drives, new memory, new ARM buildsystem).
- Our backup server was donated to us by Jussieu University, France, and we completed it with ad-hoc hard drives.

3. Allocation of Income

The balance of the association at the end of fiscal year 2011 is positive. It is proposed to apply this balance directly to the reserves of the association.

3.1 Notes

The Mageia association runs with three main assets:

- direct financial donations,
- hardware and services donations,
- · benevolent contributions from its community.

The Mageia association counts 15 active members (founders & past Council members) as of December 31st. It will have grown from the current Council members, by the next General Assembly. It is not expected, nor needed, to bring a membership fee up.

The association mission and dependance from all contributors should be made more visible.

We need a better, stronger report of the financial structure and activity of the association.
